Fellows-Alex Altair and Kaj Sotala-to support its growing research program. In
addition, SI hosted its first Workshop on Logic, Probability, and Reflection, in

in Tarski's undefinability theorem) that is expected to generate 1-3 papers. Finally,
SI continued its efforts to better understand relevant research problems/directions
through consultations with its advisors-such as Max Tegmark and Nick Bostrom - and

published a series of proposals detailing ways in which AI risk reduction might be purchased.

Program 2: Outreach

SI held its annual Singularity Summit in San Francisco. With another set of prestigious speakers including, Steven Pinker, Peter Norvig, Ray Kurzweil, and Nobel Laureate Daniel Kahneman; over 600 attendees; and coverage by the BBC, the Wall Street Journal, other popular media outlets; the Summit was once again SI's most successful outreach activity.

In addition, SI increased engagement with the AGI research community through interviews with researchers Pei Wang, Bill Hibbard, and Ben Goertzel. MIRI also sponsored a \$1,000 Prize for the Best AGI Safety Paper at the AGI-12 conference. SI also continued its outreach to the general public with the completion of Facing the Intelligence Explosion and a popular "Ask Me Anything" by Executive Director Luke Muehlhauser of Reddit.

Finally, in 2012 SI helped launch a new 501(c)3 non-profit - the Center for Applied Rationality- to continue the work SI began on rationality training. This included the execution of four rationality training workshops, each attended by 20+ participants from the general public, and a fifth rationality training workshop attended by 20+ high school students with exceptional mathematical ability.
