In 2013 the Machine Intelligence Research Institute (MIRI) successfully transitioned away from a focus on strategic and expository research to a focus on math and computer science research in Friendly AI (FAI) theory. During the year MIRI ran 5 research workshops, which accomplished its goals to (1) identify researchers MIRI might hire to work full-time on FAI theory, (2) expose additional researchers to the FAI research agenda, and (3) spur concrete progress on open problems in FAI. MIRI identified two researchers to hire, exposed more than 35 researchers to the FAI research agenda, and published 4 overviews of open problems in FAI as well as 8 technical reports (and other unpublished progress).

MIRI did continue to fund some strategic and expository research in 2013. This consisted of 4 papers published directly by MIRI, 4 journal-targeted papers, 4 chapters in a peer-reviewed book, 9 in-depth analysis blog posts, 14 short analysis blog posts, and 16 interviews with domain experts.

MIRI's new focus on technical research came with a reduced focus on outreach and community building. In 2013 MIRI gave general-audience talks about superintelligence control at universities and technology companies (Stanford, Oxford, Facebook, Quixey, and Heroku) as well as two talks on open problems in FAI at Harvard and MIT.

Additionally MIRI staff contributed to various media small writings and interviews, e.g., a short article for Quartz and an interview for Big Picture Science. MIRI also published a course guide for aspiring FAI researchers. Finally, MIRI released two ebooks of previously published material in order to make them more accessible, and hosted a book launch party for "Our Final Invention", an important popular audience book detailing the motivations behind MIRI's research program.
